"JUST ACTION: An Evening with Leah Rothstein"


INDIANAPOLIS, IN - The Fair Housing Center of Central Indiana (FHCCI) is excited to announce that housing policy expert Ms. Leah Rothstein will be our special guest speaker at "JUST ACTION: An Evening with Leah Rothstein" on Tuesday, August 1, 2023, at The Toby Theater at Newfields in Indianapolis. Ms. Rothstein is coauthor with her father, Richard Rothstein, on their new book Just Action: How to Challenge Segregation Enacted *Under the Color of Law.* This book is a follow up to Mr. Rothstein's ground-breaking civil rights book, *The Color* Law: A Forgotten History of How Our Government Segregated America, which decimated the myth that Black and white families live separately by choice and argued that government actions created our segregated communities. Building from that foundation, this new book answers the question, "How do we challenge the racial divisions in our communities?"

"The Color of Law and the Just Action follow up book are core curriculum in understanding the long-term impact of discriminatory housing policies, and how all of us can come together to challenge the continued harms of these practices." stated Amy Nelson, Executive Director of the FHCCI. "To Ms Rothstein have come to Indianapolis and share the information they uncovered is incredibly important in combating housing inequities."

Housing by the FHCCI's Executive Director, Amy Nelson, will occur. This will set the stage for Ms. Rothstein's presentation on the key findings from her book, which provides a critical blueprint for advocates, community leaders, and concerned residents alike in redressing residential segregation. A Q&A session with Ms. Rothstein and a book signing will close out the evening.

Attendees will learn about solutions being implemented nationwide to address housing inequities and a call to action for our community and state. *Just Action* highlights work being done to expand inclusionary zoning, challenge evictions, expand homeownership opportunities, homeowner repair programs to combat displacement, real estate sales steering investigations, housing choice voucher protections, and other actions to counteract housing barriers. The FHCCI was honored to have its work in challenging modern-day forms of redlining and other lending practices highlighted in Chapter 9 as part of *Just Action's* "solutions."

A FHCCI goal in presenting this event is to bring those interested in working together to seriously challenge segregation and discrimination. To create true housing change, there needs to be involvement from a diverse group of people and organizations, including housing consumers, concerned citizens, attorneys, housing advocates, government officials, housing providers, lenders, real estate agents, policy makers, and more. Attendance is free but advance registration is required to ensure adequate seating. Continuing Legal Education credits have also been approved for Indiana practicing attorneys.
