ACPL Sheds Light on Housing Discrimination with "Unwelcomed" Exhibit

(FORT WAYNE, IN) – Today, the Allen County Public Library's (ACPL), in partnership with the Fair Housing Center of Central Indiana (FHCCI), will host an interactive, traveling exhibit called "Unwelcomed: A Fair Housing History of Sales & Lending Discrimination." The exhibit will be on display in the Great Hall of the Main Library through March 3, coinciding with Dr. Martin Luther King, Jr. Day and will be on display through Black History Month to draw attention to the intersections of housing discrimination and racism throughout history.

This multi-panel exhibit educates participants on the historical and systemic barriers that have impacted today's neighborhoods through the use of redlining, racial covenants, steering, neighborhood intimidation, and other forms of housing discrimination. Modern-day forms of housing discrimination in sales and lending are also highlighted in the exhibit. The exhibit presents historic documents and news stories, as well as interactive QR codes with additional information and links for the viewer to explore.

"Every February, we strive to celebrate the contributions and successes of Black leaders and the Black community, while also drawing attention to racial injustices that still exist," said ACPL Director of Community Partnerships and Programs Beth Boatright. "When the FHCCI approached us about the exhibit, we knew it would a perfect complement to our Black History Month programming for 2025."
